1.1 Getting started

1.1.1 Overview

Sphinx offers a built-in LaTeX builder which can produce pretty PDF documents. It requires PDF documents to be declared in the <code>conf.py</code> file, see the latex_documents setting. That works for simple projects, but is not flexible enough for projects which create multiple PDFs with varying templates and parameterization.

This extension provides a new LaTeX builder which determines which PDFs to generate from declarations in line in the reStructuredText source. Those declarations, in the form of reST directives, allow various parameters to be set in the LaTeX output, such as which document class to use, custom parameters, etc.

Install this package using pip install sphinxcontrib-multilatex, or from source using python setup.py install. Then add it to your project's Sphinx configuration file conf.py:

1.3 Extension internals

1.3.1 References between distinct PDF documents

Sphinx references point to the source file of their targets. That matches the HTML builder well, because generally one source file turns into one HTML output file. However, the LaTeX builder generally puts multiple source files into a single output file.

- 1. Collect latex_document nodes: iterate over all source files and traverse their doctrees.
- 2. Assemble doctrees of latex_document nodes: use Sphinx' built-in assembling logic.
- 3. Determine which source files went into which latex_document nodes: traverse the doctree of each latex_document node looking for start_of_file nodes.
