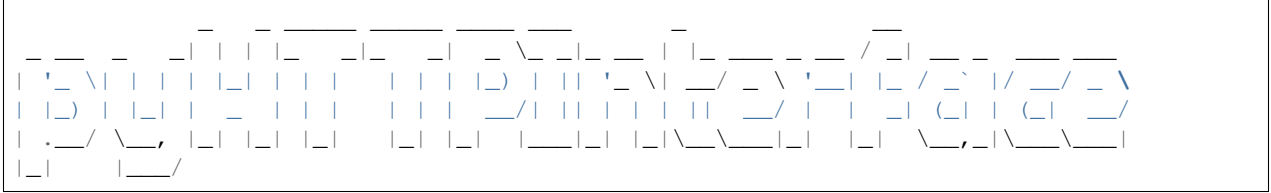

TERMS AND CONDITIONS FOR USE, REPRODUCTION, AND DISTRIBUTION

2.7.1 1. Definitions.

“**License**” shall mean the terms and conditions for use, reproduction, and distribution as defined by Sections 1 through 9 of this document.
